ARTICLES OF AMENDMENT OF

ARTICLES OF INCORPORATION OF

ONAMAC ASSOCIATION INCORPORATED

Articles of Amendment of the Articles of Incorporation of Onamac Association Inc., are hereby executed by the Corporation pursuant to the provisions of Revised Code of Washington 24.03.170 and 24.03.175 as follows:

- 1. The Name of the Corporation is presently ONAMAC MAINTENANCE ASSOCIATION INC.
- 2. The amendment to the Articles of Incorporation of the Corporation is as follows:
 - a. Article VII, entitled "Limitation of Directors' Liability" is hereby added and shall read as follows:

ARTICLE VII

LIMITATION OF DIRECTORS' LIABILITY

A Director shall have no liability to the Corporation or its members for monetary damages for conduct as a Director, except for acts or omissions that involve intentional misconduct by the Director, or a knowing violation of law by the Director, or for any transaction from which the Director will personally receive a benefit in money, property or services to which the Director is not legally entitled. If the Washington Nonprofit Corporation Act is hereafter amended to authorize corporate action further eliminating or limiting the personal liability of Directors, then the liability of a Director shall be eliminated or limited to the full extent permitted by the Washington Nonprofit Corporation Act, as so amended. Any repeal or modification of this article shall not adversely affect any right or protection of a Director of the Corporation existing at the time of such repeal or modifications for or with respect to an act or omission of such Director occurring prior to such repeal or modification.

3. The amendment was adopted at the Annual Meeting of the Members of the Corporation held on June 28, 1998. A quorum of the members was present at the meeting and this amendment received a majority of the votes which members present at the meeting (or represented by proxy) were entitled to cast.
